EQUIPMENT:

Equipment and systems covered by this certificate are as follows:

Description of equipment

The ammeter is an Ex component, it consists of an enclosure, a cover frame, a protection cover, a foundation, a transparent shield, a measuring mechanism etc. The ammeter can produce 2 times to 5 times overload. The ammeter can be connected with 5A or 1A external-attached current transformer.

Rating

Measuring Scope: 0-40mA, 0-1A,0-5A Rated service temperature range: -20°C to +80°C

Schedule of limitations

- 1. The ammeter must be mounted in the enclosures which conform to the requirements of a recognized type of protection as specified in IEC 60079-0:2011, and the degree of protection of that enclosure shall be IP54 at least.
- 2. When the ammeter is installed into the enclosures designed to type of protection increased Safety "e". The creepage distance and clearance between the terminals and other live or earthed parts inside the enclosure shall comply with the requirements of clauses 4.3 and 4.4 and table 1 of IEC 60079-7.
- 3. Tightening torque of terminal screw is 3.2Nm.
- 4. An electric strength test, in accordance with IEC 60079-7:2006 clause 7.1 shall be carried out on all units when they have been incorporated into equipment.
