EQUIPMENT:

Equipment and systems covered by this certificate are as follows:

The intrinsically safe, rugged smartphone type IS310.2 is designed for voice and data communications in explosion hazardous areas of zone 2 and 22. It is equipped with cameras (also no camera version is available), torch, GPS, acceleration sensor, Dual-SIM, vibration motor, 3G, Bluetooth, WLAN and NFC technology. The software is based on the ANDROID operating system.

SPECIFIC CONDITIONS OF USE: YES as shown below:

The battery pack shall be changed or charged only outside ex-hazardous areas. The device must be protected from impacts with high impact energy, against excessive UV light emission and high electrostatic charge processes. The permitted ambient temperature range is -20°C to +60°C.
